Terms and Conditions – General Information

What Your Program Cost Includes: Review the program description to be sure you know what's included in the "Land Only" program cost and what's not. Included are all events, activities, visits, tastings, described ground transportation, hotel overnights, and meals as described in the program description. Airfare is not included. Not included are personal costs or expenses such as laundry, postage/shipping, phone calls, hotel incidentals, wine purchases or other non-program beverages.

Cancellation and Refunds: Cancellations must be received in writing. Cancellation fees are as follows:

Deposits are non-refundable

Cancellations received from 61 days to 89 days prior to program start – 50% of program cost

Cancellations received within 60 days prior to program start – 100% of the program cost

Arrivals and Departures: The program begins and ends at the place and times stated in the program description. In the event a participant is early or late at the arrival point and/or early or late leaving at the end of the program, she/he is responsible for arranging her/his own transfers and any other costs or expenses. Pickup or drop-off other than stated in the program description will be accommodated if possible and must be arranged at least 30 days in advance of program start.

Program Minimum Size and Cancellation: We reserve the right to cancel the program in the event that enrollment does not reach the budgeted minimum participants at least 90 days in advance of program start. In the event of cancellation due to not meeting minimum enrollment, all deposits will be refunded.

Non-Refundable Airline Tickets and Reservations: We do not recommend the purchase of non-refundable airline tickets and we are not responsible for expenses incurred by participants who book such tickets or make other non-refundable reservations until the minimum enrollment for the program has been reached. Should you be considering making such reservations anyway, be sure to check with me as to the enrollment status of the program.

Itinerary Changes: In the event that a planned vendor or supplier is unable to deliver the services, we reserve the right to alter the itinerary or arrangements. We will make best efforts to substitute another vendor or supplier. Such alterations or changes may be made without prior notice or liability or penalty.
